## **Topics Covered :**

It has been another busy year or so on the insolvency front. There is lots for practitioners to get to grips with from a landmark Supreme Court case on directors' duties and insolvency to problem cases involving whether one-director companies fulfil the quorum requirements of the *Model Articles*. This course covers key developments in corporate and personal insolvency over the last year or so. The course concentrates on developments of most practical interest to lawyers generally and is not limited in scope to those who solely practice in this area. The course will include but is not limited to:

- *Re Jones* [2023] EWHC 1359 what does '*carried on business*' mean for the purpose of jurisdiction to make a bankruptcy order?
- Pately Wood LLP v Kicks [2022] EWHC 2973 on setting aside the decision of a trustee in bankruptcy for being perverse
- Khan v Singh-Sall [2022] EWHC 1913 reaffirming the high bar for annulling a bankruptcy order
- Kaye v Lees [2023] EWHC 758 on injunctions to prevent a Mental Health Crisis Moratorium or Breathing Space Moratorium
- BTI 2014 LLC v Sequana SA [2022] UKSC 25 the Supreme Court rules on directors' duties to creditors on insolvency
- *Mitchell v Al Jaber* [2023] EWHC 364 on directors' duties post liquidation
- Limitation periods for fraudulent trading Tradition Financial Services Lit v Bilta (UK) Ltd [2023] EWCA Civ 112
- Challenging an IVA for 'material irregularity' Moorgate Industries Inc Ltd v Mittal [2022] EWHC 3009
- One-director companies and quorum Re Fore Fitness Investments Holdings Ltd [2022] EWHC 191
  & Re Active Wear Ltd [2022] EWHC 2340
